4. FIRST AID MEASURES

EYES: Protect unharmed eye. Remove contact lenses, if worn. Rinse opened eye for several minutes under running water, then consult a doctor.

SKIN: Immediately remove any clothing soiled by product. Immediately rinse with water. If skin irritation continues, consult a doctor. Seek immediate medical help for blistering or open wounds.

INGESTION: Rinse out mouth and then drink plenty of water. Do not induce vomiting; immediately call for medical help.

INHALATION: Supply fresh air; consult a doctor in case of complaints. Provide oxygen treatment if affected person has difficulty breathing. In case of irregular breathing or respiratory arrest, provide artificial respiration.

SIGNS AND SYMPTOMS OF OVEREXPOSURE

ACUTE EFFECTS: Breathing difficulty, coughing, caustic effect on skin and mucous membranes, strong irritant with the danger of severe eye injury. Gastric or intestinal disorders when ingested. Nausea in case of ingestion. **Danger** of gastric perforation.

ADDITIONAL INFORMATION: Immediately remove any clothing soiled by the product.

Symptoms of poisoning may even occur after several hours, therefore medical observation is required for 48 hours after exposure.

If necessary, treat with oxygen respiration treatment.

5. FIRE FIGHTING MEASURES

GENERAL HAZARD: Formation of toxic gases is possible during heating or in case of fire.

EXTINGUISHING MEDIA: CO₂, extinguishing powder, or water spray. Fight larger fires with water spray or alcohol resistant foam.

FIRE FIGHTING PROCEDURES: Use water spray to cool unopened containers.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

HANDLING: Prevent formation of aerosols. Avoid splashes or spray in enclosed areas. Use only in well ventilated areas.

STORAGE: Use only receptacles specifically permitted for this product. Aluminum is an unsuitable material to use as receptacle.

Store away from foodstuffs. Store away from oxidizing agents. Do not store together with alkalis (caustic solutions). Store away from metals.

Store in cool, dry conditions in well sealed receptacles. Keep containers tightly sealed.

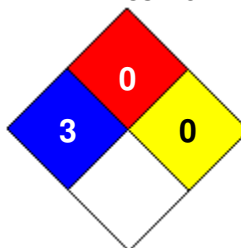
